"We The People" do ordain and establish to our "Civil Servants" within the Constitution for the united States of America. Bill of Prohibitions Amendment VI [6] Title; Speedy and public trial, by an impartial jury: "In all criminal prosecutions, the accused shall enjoy the right to a speedy and public trial, by an impartial jury of the State and district wherein the crime shall have been committed, which district shall have been previously ascertained by law, and to be informed of the nature and cause of the accusation; to be confronted with the witnesses against him; to have compulsory process for obtaining witnesses in his favor, and to have the Assistance of Counsel for his defense."

Bill of Prohibitions Amendment VII [7] Title; No fact tried by a jury, shall be otherwise reexamined in any Court of the United States: In suits at common law, where the value in controversy shall exceed twenty dollars, the right of trial by jury shall be preserved, and no fact tried by a jury, shall be otherwise reexamined in any Court of the United States, than according to the rules of the common law.


Federal Law united States Code Title: 18 Crimes And Criminal Procedures. Chapter 1 Title: General Provisions. Section 2 Title: Principals.

Subsection (a) "Whoever commits an offense against the United States or aids, abets, counsels, commands, induces or procures its commission, is punishable as a principal."

Subsection (b) "Whoever willfully causes an act to be done which if directly performed by him or another would be an offense against the United States, is punishable as a principal."
